The Opportunity

This is a rare 575 m² commercial unit in Belenzinho, offered through a private auction (leilão particular) conducted by D1LANCE. The property is a single large open-plan retail/commercial space with an active glass storefront facing the street, ready to operate with minimal adaptation.

The unit was previously rented for R\$ 35,000 per month, giving a real reference point for income potential. It is offered with a minimum opening bid of R\$ 1,150,000, a 77% discount to its appraised value of R\$ 5,000,000.

Why This Property

- **Clean title:** no liens, encumbrances, or outstanding debts on the property; property tax (IPTU) is current.
- **No condominium fee:** the unit is not tied to the residential building's condominium and carries no monthly condo charge.
- **Proven income potential:** previously leased for R\$ 35,000/month.
- **Strategic location:** close to metro stations, major avenues, and commercial hubs; also near Brás, the region's fashion, wholesale, and distribution hub.
- **Ready infrastructure:** changing room, restrooms, and kitchen already installed, in addition to the main hall, so no major structural work is needed to begin operating.
- **Loading access:** side entrance for goods and deliveries.
- **Nearby parking:** two paved parking spaces in front of the property, available by arrangement.
- **Documentation in order:** title, appraisal report, and certificates have already been gathered and are available for review.

How the Private Auction Process Works

A leilão particular (private auction) is conducted directly by the property's owner (the Comitente), under rules set out in the auction's own edital (the governing legal notice). The process for this specific lot works as follows:

1. Bids are submitted exclusively online through d1lance.com.br, during the auction window listed above.
2. For this lot, bids are conditional: the winning bid is subject to review and approval by the Comitente before the sale is confirmed. If the bid is not approved, the auction is closed with no sale and no right to compensation for the bidder.
3. If approved, the buyer must pay the full bid amount, in cash, within 120 hours, together with the auctioneer's 5% commission.
4. Once payment is confirmed, the sale is formalized through a public deed (Escritura Pública), and possession is transferred once the property is vacated.
5. The buyer then registers the deed at the Real Estate Registry Office (Cartório de Registro de Imóveis) to complete the transfer of ownership.

Because bids are irrevocable once submitted, and this is a cash-only, single-payment auction, we strongly recommend having financing and documentation fully ready before bidding.

Who Can Participate

Both Brazilian and foreign buyers can take part, provided they complete registration and are approved for bidding. In addition to standard identification documents, foreign buyers must also prove their legal stay in Brazil, and cannot claim unfamiliarity with Brazilian law as grounds to challenge the auction's terms.

- **Individuals:** government ID / passport, taxpayer ID (CPF), and proof of address.
- **Companies:** articles of incorporation, company tax ID (CNPJ), and documents identifying legal representatives.
- **Foreign buyers:** the documents above, plus proof of legal residence or authorized stay in Brazil.
- **Representation by a third party:** requires a notarized power of attorney (procuração) with specific authority to acquire the property.

If you do not yet hold a CPF or CNPJ, or need guidance on registering as a foreign buyer, our team can point you in the right direction before the auction closes.

How to Participate: Step by Step

1. Review the auction's official edital and the property's title (matrícula). See "Where to Find the Documents" below.
2. Create a free account on d1lance.com.br.
3. Request habilitação (bidder approval) for this specific auction (P26089).
4. If desired, request a property viewing through our team (see contact details below).
5. Once approved, submit your bid online before the auction closes on September 23, 2026, at 3:00 PM (Brasília time).
6. If your bid is approved by the Comitente, complete payment in full, in cash, within 120 hours.
